This refers to the special inspection conducted by Mr. J. L. Coley of this office on June 21 - 24, 1983, of activities authorized by NRC Operating License Nos. DPR-33, DPR-52 and DPR-68 for the Browns Ferry facility. Our preliminary findings were discussed with Mr. J. A. Coffey, Plant Superintendent, at the conclusion of the inspection.

Areas examined during the inspection and our findings are discussed in the enclosed inspection report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector.

During the inspection, it was found that certain activities under your license appear to violate NRC requirements. This item and references to pertinent requirements are listed in the Notice of Violation enclosed herewith as Appendix A. Elements to be included in your response are delineated in Appendix A.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC's Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter.
