Gentlemen:

This refers to the inspection conducted by Mr. W. L. Holley of this office during the period November 14-18, 1983, of activities authorized by NRC Operating License DPR-40, for the Fort Calhoun Station, and to the discussion of our findings with you and other members of your staff.

Areas examined during the inspection included radiation protection procedures; instrumentation and equipment; exposure control; posting, labeling, and control; surveys; notifications and reports; and NUREG-0737 open items. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are documented in the enclosed inspection report.

During this inspection, it was found that one of your activities was in violation of NRC requirements. Consequently, you are required to respond to this violation, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation with this letter.

The violation identified in this inspection is a repeat of a violation noted during a previous inspection conducted during December 1982 (Inspection Report 50-285/82-30). We are concerned that proper management controls have not been implemented to prevent recurrence of this violation.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).

The response directed by this letter and the accompanying Notice is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, PL 96-511.
