Nicholas of this office during the period December 19-22, 1983, of activities authorized by NRC Construction Permit CPPR-126, for Comanche Peak Steam Electric Station, and to the discussion of our findings with Mr. R. A. Jones and other members of your staff at the conclusion of the inspection.

Areas examined during this preoperational inspection of your chemistry/ radiochemistry program included outstarding open items in the following functional areas: organization, staffing, staff qualifications, training program, secondary chemistry program, secondary chemistry sampling system, controls of effluent releases, audits and review of chemistry/radiochemistry activities, and administrative and departmental procedures. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These inspection findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.
