Subject: Enforcement Conference

This refers to the Enforcement Conference held with you and other members of your staff and Mr. J. M. Allan and other members of the Region I staff on September 1, 1983. The conference was held at our request to discuss the findings of a special radiation protection inspection conducted at the Beaver Valley Power Station, Unit 1, on August 5, 1983.

The subjects discussed during this conference are described in the NRC Region I Enforcement Conference Report which is enclosed with this letter.

It is our opinion that the conference was beneficial and improved our understanding of the circumstances surrounding, and your corrective actions taken for the unplanned personnel occupational radiation exposure event which occurred on August 4, 1983.

We are considering appropriate enforcement action for this event. Our decision on this matter will be the subject of future correspondence.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.

No reply to this letter is required. Your cooperation is appreciated.
