This is in response to Niagara Mohawk Power Corporation's letter dated August 24, 1983, regarding changes to the Nine Mile Point Unit 1 Security and Safeguards Contingency Plans transmitted as part of Issue 2, Revision 0, to the plans.

We have reviewed the information contained in these plan revisions and have determined that portions of the revisions are consistent with the provisions of 10 CFR 50.54(p), and are considered acceptable.

However, certain other portions of the revisions are not considered acceptable for the reasons stated in the enclosure to this letter. For these portions, you are to revert to the previously approved plan wording or, modify your plan to accommodate the attached comments. Corrected page revisions should be submitted to this office within 30 days of the receipt of this letter.

If you wish to pursue changing the plan with respect to those portions not considered acceptable, you should submit the changes under the provisions of 10 CFR 50.90.

The enclosures to your above referenced letter and the enclosure to this letter are being withheld from public disclosure since they contain Safeguards Information and must be protected in accordance with provisions of 10 CFR 73.21.
