
This refers to the inspection conducted by Messrs. S. L. McCrory and M. E. Murphy of this office on February 6-9, 1995. The inspection included an assessment of the qualifications of seven individuals who had applied for licenses to operate your Arkansas Nuclear One, Unit 1, facility. At the conclusion of the inspection, findings of generic significance were discussed with you and those members of your staff identified in the enclosed report. Appropriate licenses have been issued to all seven applicants, who successfully completed all portions of their examinations.

Areas examined during the inspection are identified in the report. Within these areas, the inspection included evaluation of license applicants by the administration of comprehensive written and operating examinations. The results of this inspection are documented on page 1 in the enclosed report.
