SUBJECT: NRC INSPECTION REPORT 50-382/95-12

This refers to the inspection conducted by T. W. Dexter of this office assisted by other NRC and U.S. Army personnel on January 30 through February 2, 1995. The inspection included a review of security program activities authorized for your Waterford Steam Electric Station, Unit 3, facility. At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the enclosed report.

Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

One Unresolved Item was identified concerning the implementation of the behavioral observation program. This matter is discussed in Section 1.5 of the enclosed inspection report.

An Inspection Followup Item was identified regarding testing results of the intrusion detection system. This matter is discussed in Section 1.6 of the enclosed inspection report.

The material enclosed herewith contains Safeguards Information as defined by 10 CFR 73.21 and its disclosure to unauthorized individuals is prohibited by Section 147 of the Atomic Energy Act of 1954, as amended. Therefore, the material will not be placed in the Public Document Room.


