This refers to the inspection conducted by J. L. Montgomery of this office during the period August 15-19, 1983, of activities authorized by NRC Operating License DPR-40 for the Fort Calhoun Station, and to the discussion of our findings with you, and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection included protective action decisionmaking, notifications and communications, changes to the emergency preparedness program, shift staffing and augmentation, training, and dose calculation and assessment. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspector. The inspection findings are documented in the enclosed inspection report.

Within the scope of the inspection. no violations or deviations were identified.

We have also examined actions you have taken with regard to previously identified inspection findings. The status of these items is identified in paragraph 4 of the enclosed report.
