Arkansas Nuclear One - Unit 1 (ANO-1) submitted proposed Technical Specification (TS) changes relocating additional cycle-specific parameter limits to the Core Operating Limits Report (COLR) by letter dated August 10, 1994, 1CAN089401. The changes were requested to support restart from refueling outage 1R12, which began on February 14, 1995.

Subsequent discussions with the NRC staff have indicated that a listing of those parameter limits that have been relocated must be added to the COLR description in TS 6.12.3.1 for the previously submitted change request to be acceptable. This supplement to the August 10, 1994 letter contains proposed TS pages incorporating the requested listing.

The proposed changes to TS 6.12.3.1 incorporate a listing of those cycle-specific parameter limits relocated by incorporation of Amendment 159, dated April 14, 1992, in addition to the parameter limit relocations proposed in our August 10, 1994 submittal. The incorporation of the listing imposes no new requirements, results in no reduction of any TS requirements, and is considered to be strictly administrative in nature. The no significant hazards considerations determination performed for the August 10, 1994 submittal is also applicable to the administrative changes attached to this supplementary submittal.

Although this request is neither exigent nor emergency, your prompt review is requested. Criticality during the restart of ANO-1 from refueling outage 1R12 is currently scheduled to occur on March 20, 1995.
