Subject: Combined Inspection Nos. 50-317/84-02; 50-318/84-02

This refers to the routine safety inspection conducted by Mr. D. J. Collins of this office on January 9-13, 1984 of activities authorized by NRC License Nos. DPR-53 and DPR-69 and to the discussions of our findings held by Mr. Collins with Mr. L. B. Russell of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection of your Radiological Safety Program consisted of selective examinations of procedures and representative records, interviews with personnel, measurements made by the inspector, and observations by the inspector.

Our inspector also verified the steps you had taken to correct the violations brought to your attention in a letter dated May 16, 1983. We have no further questions regarding your actions at this time.

Within the scope of this inspection, no violations were observed. The inspection indicated that the Radiation Protection Program at the Calvert Cliffs Nuclear Power Plant was properly implemented. In addition, audits performed of the Radiation Protection Program were commendable.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
