1. Faulty Electrical Construction

This allegation was made by an unidentified individual to the intervenor, Patricia Lee Hourihan, and was brought up at the ASLB hearings. The NRC has interviewed the individual who made the allegation and will investigate his specific concerns.

2. Improper Heat Treatment

This allegation was made by Charles Wright at the ASLB hearing and has been addressed by Bechtel and APS.


4. Improper Electrical Work
