Subject: Deletion of Home Telephone Numbers, Unlisted Utility Numbers, etc. from Emergency Plans

> Byron Station, Units 1 and 2 Braidwood Station, Units 1 and 2

By Generic Letter No. 81-27 dated July 9, 1981, we advised licensees and applicants that:

When emergency plans and implementing procedures, or changes thereto, are submitted in the future, please mark all pages which have privacy or proprietary material, bracket the specific information involved, and identify these pages in the transmittal letter.

During the past two years the NRC has reviewed emergency plans and emergency plan supplements to delete home telephone numbers, unlisted utility numbers. and periodically social security numbers even when no request for these deletions were made as required by Generic Letter No. 81-27. It has been our experience that seldom do licensees and applicants request deletion of information in the emergency plans or their supplements. This is to advise you that we do not intend to review emergency plans to delete privacy or proprietary information unless you specifically request that the information be deleted as required by the July 9 letter. Therefore, absent such a request, the entire plan will be placed in the NRC's Public Document Room in Washington, D. C. and in the Local Public Document Room located near your plant site.
