Also included is a revision to the Callaway Radiological Emergency Response Plan (RERP). These changes have been discussed with NRC at meetings on January 20, 1984, February 8, 1984 and February 21, 1984. For user convenience, Revision 7 to the RERP is packaged separately from the remainder of Revision 7. This is done to facilitate distribution of the RERP to personnel in addition to the normal FSAR holders.

Revision 7 includes a clarification to our commitment concerning NUREG-0737, Item II.B.4, Training for Mitigating Core Damage. This training meets the intent of the INPC guidelines and will be complete for all SRO's, RO's, and STA's prior to fuel load.
