Gentlemen:

This refers to the inspection conducted by Messrs. J. R. Boardman and W. F. Smith of this office during the period November 14-18, 1983, and November 28 through December 1, 1983, of activities authorized by NRC Construction Permit CPPR-147 for the Wolf Creek Generating Station, and to discussion of our findings with you and other members of your staff.

Areas examined during the inspection included your quality assurance program in the areas of quality assurance records, audits, procedures, and design control. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

During this inspection it was found that certain of your activities were in violation of NRC requirements. Consequently, you are required to respond to these violations, in writing, in accordance with the provisions of Section 2.201 of the NRC's "Rules of Practice," Part 2, Title 10, Code of Federal Regulations. Your response should be based on the specifics contained in the Notice of Violation enclosed with this letter.

During this inspection it was found that certain of your activities appeared to deviate from your commitment made to the NRC. This item and reference to your commitment is identified in the enclosed Notice of Deviation. You are requested to respond to this deviation in writing. Your response should be based on the specifics contained in the Notice of Deviation enclosed with this letter.

Four unresolved items are identified in paragraphs 5, 6, 7, and 8 of the enclosed inspection report.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosures will be placed in the NRC Public Document Room unless you notify this office, by telephone, within 10 days of the date of this letter, and submit written application to withhold information contained therein within 30 days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1).
