Subject: Combined Inspection 50-277/84-01; 50-278/84-01

This transmits the findings of a special safety inspection the NRC staff conducted January 5 - 20, 1984 at the Peach Bottom Atomic Power Station, Delta, Pennsylvania. These findings were based on observation of activities, interviews, do ment reviews and information obtained at a management meeting held onsite on January 12, 1984, as part of this inspection.

The results of these efforts indicate a problem with your internal review process for identifying and evaluating potential unreviewed safety questions. In particular, administrative procedures were apparently followed in preparing an alternative approach for reactor shutdown; however, the safety evaluation conducted by the Plant Operations Review Committee which approved the alternate approach was inadequate to assess the safety implication of the adopted approach. Specifically, in 1977, procedures were developed to bypass the automatic features of the Rod Worth Minimizer (RWM) and Rod Sequence Control System (RSCS) as an alternative during normal reactor shutdowns. These systems are described in your Safety Analysis Report (FSAR) and are designed to automatically provide a rod positioning arrangement that could accomodate a dropped control rod without adverse safety consequences.

Control rod drop accidents are of concern during both reactor startup and reactor shutdown. As a result of discussions with your staff during the inspection, we are aware of the technical reasons why you consider this matter to be ameliorated during shutdowns at your plants. Nonetheless, we are concerned that your station procedures allowed a procedure for an alternative shutdown method (by individual rod scramming) to be developed without adequately addressing the safety implications of the alternative methods. Following receipt of this letter, please contact us promptly to arrange for a mutually agreeable date and time for an enforcement conference. At that conference, you should be prepared to discuss the violations of NRC requirements and the unresolved items addressed in Details, Paragraph 4 of the enclosed inspection report as well as any additional information you may have gathered since the end of that inspection period.

Details 3.2.1, 3.2.2, and 4.2.2 of the enclosed report also describe commitments your staff made in partial response to issues we raised during this inspection. In addition, your staff also indicated that (1) the reactor vendor was preparing a technical assessment of this matter in response to your request, (2) individual rod scramming to effect a reactor shutdown would not be resumed unless that as-

sessment concluded that no safety hazard existed, and (3) Philadelphia Electric would not resume that practice until we have reviewed that assessment and concur in its conclusions. If your understanding of these commitments differs from the descriptions in this letter and report, please advise us immediately.

Such application must be consistent with the requirements of 2.790(b)(1).
