This refers to the inspection conducted under the Resident Inspection Program by Messrs. G. L. Constable and T. A. Flippo of this office during the period July 1 through August 31, 1983, of activities authorized by NRC Construction Permit CPPR-103 for the Waterford Steam Electric Station, Unit 3, and to the discussion of our findings with members of your staff at the conclusion of the inspection.

Areas examined during the inspection included allegations, preoperational test witnessing, American Bridge Division U. S. Steel (structural steel), drug awareness program, operator exams, human engineering walkdown, and poison assemblies. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observations by the inspectors. These findings are documented in the enclosed inspection report.

Within the scope of the inspection, no violations or deviations were identified.

One open item is identified in paragraph 8 of the enclosed inspection report. One open item is closed in paragraph 11.
