SUBJECT: FORT ST. VRAIN NUCLEAR GENERATING STATION, AMENDMENT NO. 36 TO FACILITY OPERATING LICENSE DPR-34

The Commission as issued the enclosed Amendment No. 36 to Facility Operating License DPR-34 for the Fort St. Vrain Nuclear Generating Station in response to your applicat on for amendment dated April 7, 1983 (P-83134). Some changes to the proposal were made with the concurrence of your staff. This application superseded your previous applications dated April 20, 1982 (P-82112) and September 14, 1982 (P-82391). We have also included the clarifications and revised format changes which were provided in your letter dated September 28, 1983 (P-83327).

The amendment revises the Administrative Controls Technical Specifications to incorporate various editorial and format corrections and include the following NRC-requested additions: 1) plant staff composition and working hours, 2) Technical Advisor qualifications, 3) Review Committee membership, and 4) Safety Committee audit requirements. The changes to the requirements related to shift manning and overtime also completes NRC action associated with the implementation of Item I.A.1.3 of NUREG-0737, "Clarification of TMI Action Plan," November 1980.

A copy of the Safety Evaluation supporting this amendment is also attached.
