Dear Mr. Broughton:

This letter transmits the findings of the resident safety inspection conducted by Ms. M. Evans and Mr. S. Hansell from January 13, 1995 - February 18, 1995, at the Three Mile Island Nuclear Station Unit 1. The inspection consisted of document reviews, personnel interviews and observations of activities important to the health and safety of the public. The inspectors discussed the findings with you and other members of your staff at the conclusion of the inspection. Inspector observations during this report period indicate that activities were conducted safely and conservatively.

We found your evaluation and corrective actions regarding two previous violations involving ineffective corrective actions to previous events to be very good and reflected positively on your recent initiatives in the area of improving human performance. Although your evaluation and corrective actions were good, the effectiveness of future actions will depend upon the amount of management emphasis given to improving in those areas. We will continue to monitor your evaluations and corrective actions for routine incidents to determine the overall effectiveness of your initiatives.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosures will be placed in the NRC Public Document Room.
