Submittal of our plan to make the new Technical Support Center (TSC) and Operational Support Center (OSC) fully functional: November 2, 1983.

The Emergency Operations Facility is not included in this effort. Reference (A) stated that our present facilities are adequate. Though we have received indications that NRC does not concur with our position, we have received no documented indication or reason for the position being unacceptable.

Such information is essential for us to assess the available options and develop an implementation plan should one be necessary. Based on this, we shall address the EOF as a separate issue, and any commitments and plans stemming from it will be submitted six months from our receipt of the NRC's documented position.
