Gentlemen:

This refers to the routine safety inspection conducted by Mr. S. G. DuPont of this office on August 3 through September 16, 1983, of preoperational testing activities at Enrico Fermi Atomic Power Plant Unit 2 authorized by NRC Construction Permit No. CPPR-87 and to the discussion of our findings with Mr. F. Agosti and others of your staff at the conclusion of the inspection. This also refers to a Management Meeting held on October 5, 1983, between Mr. J. Streeter and others of the Region III staff and Messrs. W. Holland, F. Jens, F. Agosti, Wells and Fahner of the Detroit Edison Company staff to discuss growing NRC concerns relating to the conduct of the preoperational test program.

The enclosed copy of our inspection report identifies areas examined during the inspection and discussed during the meeting. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

During this inspection, certain of your activities appeared to be in noncompliance with NRC requirements, as specified in the enclosed Appendix. A written response is required. In your response please provide a description of your actions to improve the quality of the conduct of the preoperational test program.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure(s) will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). If we do not hear from you in this regard within the specified periods noted above, a copy of this letter, the enclosure(s), and your response to this letter will be placed in the Public Document Room.


