The Nuclear Regulatory Commission conducted a routine inspection of your facility's material control and accounting (MC&A) safeguards program on March 13-17, 1995. The inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations of activities in progress. The scope and results of the inspection are summarized in Enclosure 1 and detailed in Enclosure 2.

At the conclusion of the inspection, the findings were discussed with Mr. T. P. Winslow and other members of your staff. Within the scope of the inspection, no violations or deviations were identified, one Inspector Followup Item (IFI) was opened, and three IFIs and three violations were closed.
