Subject: Routine Inspection No. 91-01

On May 23, 1991, Messrs. Thomas K. Thompson and James P. Dwyer of this office conducted a routine safety inspection at the above address of activities authorized by the above listed NRC licenses. The inspection was an examination of your licensed activities as they relate to radiation safety and to compliance with the Commission's regulations and the license conditions. The inspection consisted of observations by the inspector, interviews with personnel, and a selective examination of representative records. In addition, our inspection examined the activities covered in your correspondence dated January 25, 1991. The findings of the inspection were discussed with you, James Goodwin, Marlene Moore and Douglas Hoes at the conclusion of the inspection.

During this inspection and our previous inspection on May 30, 1990 our inspectors reviewed your actions in response to our January 24, 1990 Confirmatory Action Letter (CAL), 1-90-001 and have determined that you have fully implemented all actions agreed upon. It is no longer necessary for you to report all future malfunctions of the teletherapy unit as indicated in item 6 of the CAL, however, you will continue to be required to report any future malfunctions in accordance with 10 CFR 20.403 or any other applicable NRC regulation.

Within the scope of this inspection, no violations were identified.

In accordance with Section 2.790 of the NRC's "Rules of Practice", Part 2, Title 10, Code of Federal Regulations, a copy of this letter will be placed in the Public Document Room. No reply to this letter is required.




