Areas examined during the inspection are identified in the report. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observation of activities in progress. The purpose of the inspection was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements.

The enclosed Inspection Report identifies activities that violated NRC requirements that will not be subject to enforcement action because the licensee's efforts in identifying and/or correcting the violation meet the criteria specified in Section VII.B. of the Enforcement Policy. Therefore, no response with respect to these matters is required.

However, the enclosed Inspection Report does identify additional examples of previous violations for failure to report to the NRC within the required time. These additional examples occurred prior to your proposed corrective actions having been completed. Therefore, you should supplement any previous responses to address the additional examples noted in the report.
