SUBJECT: NRC INSPECTION REPORT 50-445/95-08; 50-446/95-08 AND NOTICE OF VIOLATION

This refers to the inspection conducted by Mr. Lonny Eckert of the Region I office on April 10-13, 1995. The inspection included a review of activities authorized for your Comanche Peak Steam Electric Station, Units 1 and 2, facility. At the conclusion of the inspection, the findings were discussed with the members of your staff identified in the enclosed report.

Areas reviewed during the inspection are identified in the report and included your radiation protection program. Within these areas, the inspection consisted of selective examination of procedures and representative records, interviews with personnel, and observation of activities in progress. The results of this inspection are documented in the enclosed report.

Based on the results of this inspection, certain licensed activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation (Notice). The violation is of concern because it involved the failure to properly assess exposures in nonuniform radiation fields.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with 10 CFR Part 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.

The responses directed by this letter and the enclosed Notice are not subject to the clearance procedures of the Office of Management and Budget, as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96.511.


