Subject: Inspection Report No. 50-247/84-05

This refers to the routine safety inspection conducted by Mr. E. J. Wojnas of this office on February 6-10, 1984, at your Indian Point-2 plant, Buchanan, New York, of activities authorized by NRC License No. DPR-26 and to discussions of our findings held by Mr. Wojnas with Mr. Jackson and other members of your staff at the conclusion of the inspection.

Areas examined during this inspection are described in the NRC Region I Inspection Report which is enclosed with this letter. Within these areas, the inspection consisted of selective examinations of procedures and representative records, interviews with personnel, and observations by the inspector. In addition, as a result of this inspection, three improvement items were identified that are necessary to continually assure an adequate program. The staff will review these items during the Emergency Response Facility (ERF) appraisal.

Within the scope of this inspection, no violations were observed.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone, within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 10 CFR 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10-day period which you believe necessary, should be made to the Supervisor, Files, Mail and Records, USNRC Region 1, at (215) 337-5223.
