> NOTICE OF APPEAL AND EXCEPTIONS TO MEMORANDUM AND ORDER OF ATOMIC SAFETY AND LICENSING BOARD DATED JANUARY 18, 1983

Comes now the Confederated Tribes and Bands of the Yakima Indian Nation (YIN) and pursuant to 10 CFR part 2.762, does appeal to the Nuclear Regulatory Commission from the Memorandum and Order of the Atomic Safety and Licensing Board dated January 18, 1983, as follows:

1. Error of Law. Said Memorandum and Order fails to recognize YIN's sovereignty and its members' reserved treaty rights under Treaty with the Yakimas (12 Stat. 951) which under the United States Constitution is the supreme law of the land.

2. Portions of Memorandum and Order to Which Exception is taken under the aforesaid error in law.

a. Contention 11, page 6 of the Order in that it removes from consideration environmental impacts on YIN's reserved treaty rights.

b. YIN's Contention 8, at page 9 of the Order in that it fails to deal with the treaty reserved rights of YIN members to access to site area.

c. YIN's Contention 9, at page 9 of the Order in that it does not consider the effect of Skagit/Hanford regarding use and enjoyment of the reserved homeland of the YIN in the Yakima Indian Reservation.

d. YIN's Contention 10, at pages 9-10 of the Order, in that it fails to recognize the trust responsibility of the United States to YIN and the governmental status of YIN and to require consideration of YIN's impaired or abrogated treaty rights.
