Enclosed are:

1. Twenty-six (26) additional copies of RESAR-SP/90, PDA Module 1, "Primary Side Safeguards System" (Proprietary).
2. Four (4) copies of RESAR-SP/90 PDA Module 1, "Primary Side Safeguards System" (Non-Proprietary).
3. One (1) copy of an application for Withholding Proprietary Information from Public Disclosure, AW-84-15 (Non-Proprietary).
4. One (1) copy of an original affidavit, AW-82-57, (Non-Proprietary).

On October 24, 1983, Westinghouse tendered an application for Preliminary Design Approval (PDA) of RESAR-SP/90 (reference 1). This application was accompanied by fifteen (15) proprietary copies of PDA Module 1, "Primary Side Safeguards System". Since that time, the NRC has performed and completed an acceptance review and have accepted this application for docket (reference 2). Westinghouse therefore requests that the NRC formally issue the docket number for the Westinghouse application for the PDA tendered via reference 1. Consistent with the requirements of 10CFR50.30, enclosed are the requisite additional copies (both proprietary and non-proprietary) of module 1.


