To Whom This May Concern:

Acuren Inspection, Inc. ("Acuren") conducts industrial radiographic testing and inspection services under the U.S. Nuclear Regulatory Commission (the "NRC") Radioactive Materials License No. 22-27593-01 (the "License"). On October 28, 2019, Acuren provided notice to the NRC of an anticipated transaction (the "Transaction") to allow the NRC to review and consent to the Transaction pursuant to 10 C.F.R. §§ 30.34(b), and the Nuclear Regulatory Commission Consolidated Guidance About Materials Licenses, NUREG-1556 Volume 15 ("NRC Guidance").

By your letter dated February 11, 2020, NRC consented to the Transaction and requested additional notification of the Transaction's completion. Accordingly, please let this letter serve as notification that on December 20, 2019, the Transaction was completed as described in Acuren's October 28, 2019 letter.

Your letter consenting to the transaction requests a "signed copy of the merger agreement confirming completion of the transaction." However, as described in Acuren's October 28, 2019 letter, the Agreement and Plan of Merger contemplating the Transaction was dated October 22, 2019, prior to Acuren's notification to the NRC. No subsequent merger agreement was executed at the closing of the Transaction; rather, at closing the parties fulfilled their earlier (October 22, 2019) agreement. For this reason, there is no merger agreement that confirms *completion* of the Transaction. Accordingly, we are instead enclosing the Certificate of Merger filed with the State of Delaware as confirmation of the Transaction. The Certificate of Merger shows that, as described in Acuren's October 28, 2019 letter, the contemplated merger of ASP Acuren Merger Sub, Inc. into Rockwood Service Corporation was completed effective December 20, 2019.


