Dear Mr. Quay:

Enclosed is Revision 3 of the AP600 Standard Safety Analysis Report (SSAR). Attachment A lists the charters and sections included in this revision. Also enclosed are revised tables of contents for affected chapters, change page instructions, lists of effective pages, and a "roadmap" of the changes in each section. The revision is in the form of replacement sections to be inserted into the SSAR binders to replace the superseded pages. Thirty-six copies are being sent to Diane Jackson. Additionally, copies are being sent directly to ACRS Members and NRC subcontractors.

The next SSAR revision will be issued in about a month. This revision represents a further reduction in the amount of proprietary information in the AP600 SSAR.

Many of the DSER open items are closed by submittal of this revision. The itemization of those items closed by this transmittal is provided by separate cover.

The Westinghouse Electric Corporation copyright notice, proprietary information notice, application for withholding and affidavit are also attached.
