Dear Ms. Garde:

This is in response to your letter dated October 24, 1983, in which you requested, pursuant to the Freedom of Information Act (FOIA), all records related to the Inquiry Team Report on Waterford QA Allegations issued on July 14, 1983, the inspection and NRC effort leading up to that report, and the Louisiana Power and Light response to that report. This confirms the information conveyed during a subsequent telephone conversation between you and Linda Robinson.

The NRC has already made the subject Inquiry Team Report and certain related records available at the Public Document Room (PDR), as noted on enclosed Appendix A.

At this time, we are placing the 16 records, as identified on enclosed Appendix B, in the PDR. These records will be filed in folder FOIA-83-624 under your name.

In addition, Mr. Mark W. Peranich, Chief, Construction Program Section of the Reactor Construction Program Branch of NRC's Office of Inspection and Enforcement, informed my staff that he maintains a tape of a June 28, 1983, interview with individuals representing Gambit Publications, Inc., concerning this subject. However, the tape is of extremely poor quality, as noted in NRC's response to a question posed by Congressman Markey (see Appendix A, number one).
