"CONFIRMING MY TELEPHONE CONVERSATION WITH MR LEDOUX OF YOUR

OFFICE ON DECEMBER 5, 1975, WE WISH TO INFORM YOU OF AN INCIDENT PURSUANT TO THE REPORTING REQUIREMENTS OF TITLE 10, PART 20.403. DURING THE INSPECTION PROCCEDURE OF TWENTY-ONE NEW 14 TON UF6 CYLINDERS AND PRIOR TO FILLING, WE EXPERIENCED AN ABNORMAL FAILURE OF THREE 1 INCH SUPERIOR VALVES, PART NUMBER 11246. THE SUPERIOR VALVE COMPANY HAS BEEN NOTIFIED AND AN INVESTIGATION IS CURRENTLY UNDER WAY TO DETERMINE THE CAUSE OF THE PROBLEM.

THESE VALVES ARE DIFFERENTIATED FROM HUNDREDS OF OTHER VALVES THAT
WE HAVE IN SERVICE BY THE NUMBER EIGHT STAMPED UPON THE VALVE BODY.
THIS INCIDENT HAS NOT CAUSED THE RELEASE OF ANY RADIOACTIVE MATERIAL,
EXPOSURE OF ANY INDIVIDUAL, OR PROPERTY DAMAGE. THIS INCIDENT IS
BEING REPORTED SOLELY AS A PRECAUTIONARY MEASURE.
