CORRECTIONS TO 10 CFR PART 40 TO BE INCLUDED IN THE FINAL RULE

- 16. In \$40.8, paragraphs (b) and (c) are revised to read as follows:
- (c)(1) In §§40.31, 40.43, 40.44, and Appendix A, NRC Form 313 is approved under control number 3150-0120.
- 17a. In §40.43, paragraph (a) is revised to read as follows:
- (a) Applications for renewal of a specific license shall be filed on NRC Form 313 in accordance with §40.31 of this part.
- 17b. Section 40.44 is revised to read as follows:

Applications for amendment of a license shall be filed on NRC Form 313 in accordance with §40.31 and shall specify the respects in which the licensee desires the license to be amended and the grounds for such amendment.

Administrative .mendments Concerning Information Collections

This rule also is amended to delete all references to obsolete NRC Form 2 in §\$40.8(c), 40.43(a), and 40.44 and to include NRC Form 313 as the current replacement form.
