Gentlemen:

In accordance with the requirements of 10 CFR 50.54(p)(2), Georgia Power Company (GPC) hereby submits a report of changes to the Physical Security Plan (PSP) for the Edwin I. Hatch Nuclear Plant Units 1 and 2. These changes, which are administrative in nature, have been implemented to incorporate the requirements of 10 CFR 73.56 as clarified by <u>Regulatory Guide 5.66</u> (June 1991). These changes define the acceptable levels of authorization for unescorted access to protected and vital areas. No other changes are addressed in this revision.

GPC has determined the change does not decrease the effectiveness of the Plant Hatch FSP. The change, along with a justification for the determination of no uccrease in safeguards effectiveness, is presented as Enclosure 1 to this letter. Enclosure 2 contains the revised PSP pages.

The information contained in Enclosures 1 and 2 is SAFEGUARDS information, and in accordance with the requirements of 10 CFR 73.71 and with Section 147 of the Atomic Energy Act of 1954, as amended, should not be placed in the NRC Public Document Room.


