Pursuant to telephonic discussions with Mr. C. Gaskin, NMSS, and Messrs. C. Schwann and A. McQueen, Region V, the enclosure is submitted pursuant to 10CFR 50.54 (p) and does not decrease the safeguards effectiveness of the approved plan.

This revision describes changes made to improve the physical protection system at the alternate access point (AAP) and addresses other administrative and procedural changes, which are now in effect at WNP-2.

The enclosures contain Safeguards Information concerning security measures for the physical protection of Supply System facilities in which special nuclear material is used. This information is to be protected in accordance with 10 CFR 73.21.




