Dear Mr. Reed:

This refers to the routine safety inspection conducted by Messrs. R. A. Paul and A. G. Januska of this office on January 27-31, 1992, of activities at the Quad Cities Nuclear Power Station, Units 1 and 2, authorized by NRC Operating Licenses No. DPR-29 and No. DPR-30 and to the discussion of our findings with Mr. R. Bax and others of your staff at the conclusion of the inspection on January 31, 1992.

The enclosed copy of our inspection report identifies areas examined during the inspection. Within these areas, the inspection consisted of a selective examination of procedures and representative records, observations, and interviews with personnel.

Based on the results of this inspection, certain of your activities appeared to be in violation of NRC requirements, as specified in the enclosed Notice of Violation. The violation was identified by the licensee, enforcement discretion is not being exercised because the corrective actions taken for a previous non-cited violation (254/90024-01; 265/90023-01) did not prevent recurrence.

You are required to respond to this letter and should follow the instructions specified in the enclosed Notice when preparing your response. In your response, you should document the specific actions taken and any additional actions you plan to prevent recurrence. After reviewing your response to this Notice, including your proposed corrective actions and the results of future inspections, the NRC will determine whether further NRC enforcement action is necessary to ensure compliance with NRC regulatory requirements.

In accordance with 10 CFR 2.790 of the Commission's regulations, a copy of this letter, the enclosures, and your response to this letter will be placed in the NRC Public Document Room.
