DEVELOPMENT OF GENERIC RECOMMENDATIONS BASED

ON THE REVIEW OF THE JANUARY 25, 1982 STEAM

GENERATOR TUBE RUPTURE AT GINNA

As a result of the Steam Generator Tube Rupture event at Ginna, a Task Force was formed to develop the factual information and significant findings associated with the event and, thereby, provide the required data base for the development of generic recommendations. The Task Force report (NUREG-0909, NRC Report on the January 25, 1982 Steam Generator Tube Rupture at R. E. Ginna Nuclear Power Plant) was published un April 14, 1982 and a meeting on this report was held with the Commission on that date. I request that each of your Offices review the Task Force report, for the development of generic recommendations. The plant specific aspects of the event are being addressed in the restart safety evaluation being conducted by NRR. That review/evaluation is scheduled to be issued in aid-May.

In addition, the Commission suggested that the Task Force members, which were drawn from a number of Offices, be provided the opportunity to develop their recommendations drawing upon their insights gained in the NUREG-0909 Task Force review. Therefore, to the extent practical, I request that your review of this matter include input from the Task Force members in your Offices.

In order to facilitate the integration of various recommendations, I request that your recommendations for generic action be presented in a format consistent with the Task Force report; that is, recommendations should be identified with: Plant System Response; Human Factors Considerations: Radiological Consequences; Organizational Response; and Post-Event Activities.
