Gentlemen:

In accordance with 10CFR50.4, attached is the original plus three (3) copies (Copy Nos. 1-4) of Revision 23 to the Arkansas Nuclear One (ANO) Industrial Security Plan (ISP). Copies 5 and 6 are being submitted to NRC Region IV. A brief description of the changes made in this revision is included as Attachment 1 and the specific changes are shown in Attachment 2. Also included in this submittal are those changes to the ISP involving the deletion of a vital area from the plan. These changes represent Revision 22 and were approved by the Staff in letter dated December 18, 1991.

In accordance with 10CFR50.54(p), it was determined by Entergy Operations that those changes not previously reviewed by the NRC do not decrease the safeguards effectiveness of the plan and, therefore, are being implemented without prior NRC approval.

The attached material describes current and proposed security measures; therefore, Entergy Operations has determined that the attached documentation contains safeguards information as specified by 10CFR73.21. The attached documentation should therefore be handled appropriately.
