Applicant: Duquesne Light Company (DLC)

Facility: Beaver Valley Power Station, Unit 2 (BVPS-2)

Subject: Instrumentation and Control System Meeting Summary

A meeting was held on June 29, 1984 in Bethesda, Maryland with representatives from the applicant, Stone and Webster and Westinghouse. A list of attendees is presented in Enclosure 1. The purpose of the meeting was to discuss the instrumentation and control open items previously identified in the BVPS-2 draft Safety Evaluation Report (SER).

All 23 of the instrumentation and control system open items were discussed at the meeting. Enclosure 2 contains the conclusions reached for each open item. Presently, two of the items are closed (#57, #76), and one is confirmatory (#75). Five are currently under NRC review and not pending DLC action (#60, #61, #68, #69 and #70). The draft response to #72 is also under review by NRC. The remaining 14 items are open and awaiting DLC action. The information needed to resolve seven of these fourteen, however, has been identified at the meeting. Open items #64, steam generator level control, and #67, power lockout for motor-operated valves, have been identified by the applicant as backfit issues by letters dated May 30, 1984 and June 15, 1984 respectively. Resolution of these items will require additional staff/applicant interaction.

Before adjourning, the staff encouraged DLC to respond quickly to the open items pending applicant action.
