Subject: NRC Region I Enforcement Conference Report 50-311/84-25

This refers to the enforcement conference held on June 27, 1984 in the Region I office, King of Prussia, Pennsylvania, to discuss matters related to the inoperability of the Containment Ventilation Isolation - Gaseous Activity Channel on May 28, 1984. The inspection findings relating to this incident were provided in Inspection Report 50-311/84-22 dated June 19, 1984. The specific items discussed at this conference and the conference results are described in the Region I Enforcement Conference Report which is enclosed with this letter.

At the Enforcement Conference, the safety significance and corrective actions for this event and other recent violations as discussed in Inspection Reports 50-272/84-08; 50-311/84-08 and 50-272/84-15; 50-311/84-15 were discussed. We are considering this information in our determination of the appropriate enforcement action. The enforcement action related to this matter will be forwarded by separate correspondence.

In accordance with 10 CFR 2.790(a), a copy of this letter and the enclosure will be placed in the NRC Public Document Room unless you notify this office, by telephone within ten days of the date of this letter and submit written application to withhold information contained therein within thirty days of the date of this letter. Such application must be consistent with the requirements of 2.790(b)(1). The telephone notification of your intent to request withholding, or any request for an extension of the 10 day period which you believe necessary, should be made to the supervisor, Files, Mail and Records, USNRC Region I, at (215) 337-5223.
