This letter refers to the routine safeguards inspection conducted by Mr. E. King of this office, and observed by B. Korona, also of this office on February 24-28, 1992, at Buchanan, New York of activities authorized by NRC License No. DPR-26 and to the discussions of our findings held by Mr. King with Mr. M. Evans, and other members of your staff at the conclusion of the inspection.

Areas examined during the inspection are described in the enclosed NRC Region I Inspection Report. Within these areas, the inspection consisted of selective examinations of security procedures and representative records, interviews with personnel and observations by the inspectors. Additionally, the inspectors examined Fitness-for-Duty (FFD) items remaining open after our initial inspection of the FFD program, conducted March 5-8, 19 and 21, 1991.

We found that your physical security program is effective and directed toward assuring public health and safety. Based on several program enhancements, management support for the program was evident. We also found that your actions to resolve open FFD issues were, in general, thorough and prompt. No violations or safety concerns were identified.
