SUBJECT: NRC INSPECTION REPORT NO. 50-395/92-02

This refers to the motor-operated valve inspection conducted by U. S. Nuclear Commission Region II at your Summer facility from January 27-31, 1992. The inspection consisted of a review of the program you developed in response to Generic Letter 89-10, "Safety-Related Motor-Operated Valve Testing And Surveillance." Areas examined during the inspection are discussed in the enclosed inspection report.

At the conclusion of the inspection, the findings were discussed with those members of your staff identified in the report. It was determined that you had developed a basic program which adequately addresses most of the generic letter recommendations. However, some concerns were identified. As denoted in the Results section of the inspection report, a written response is requested for two of the concerns. Your program does not require all of the testing recommended in the generic letter. The second concern is related to the practice of having torque switches bypassed and the valve close operation being controlled by closed limit switch. Please inform us in writing, within 60 days, of your planned actions and schedule to address this concern.

In addition, the inspection identified a number of strengths as-well-as several concerns which do not require a response. These are listed in the inspection report Summary. All of the concern are discussed in Section 3 of the inspection report.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter and its enclosure will be placed in the NRC Public Document Room.

The responses directed by this letter and the enclosure is not subject to the clearance procedures of the Office of Management and Budget as required by the Paperwork Reduction Act of 1980, Pub. L. No. 96.511.
