Re-serialization of Preservice
Relief Request Number

With reference to the Mississippi Power & Light (MP&L) Company's letter AECM-83/0424, dated August 25, 1983, this letter re-serializes the Preservice Relief Request Number 00024 as Number 00014.

The above mentioned relief request pertains to a relief from ASME Section XI Code requirements for the Preservice Inspection of the nozzle inside radius section of the Residual Heat Removal Heat Exchanger for the Grand Gulf Nuclear Station (GGNS) Unit 1 in accordance with 10CFR 50.55a(g)(5)(IV).

The existing numbering system for relief requests has been revised to avoid confusion between preservice and inservice inspection relief requests. A new log and numbering system will be utilized for ISI Plan requests, using the prefix letter I, e.g., I-00001. The existing log and numbering system will be used for preservice relief requests only. Relief request numbers 00001 through 00008, 00012 and 00014 have been assigned for preservice and any future preservice requests will follow sequentially. Request numbers 00009 through 00011, and 00013 have been assigned to inservice inspection only. These numbers have been voided from the preservice log and will not be reused.

A table attached herewith provides a cross reference between the old and new numbering systems.


