-Incorporate changes to written examinations and/or simulator scenarios as appropriate

-Administer written examination at plant site

-Administer up to 4 operating examiantions at plant site

-Grade operating examinations

-Grade written examinations

-Update Examination Question Bank

-Attend exit briefing with facilty

### B. PERIOD OF PERFORMANCE
