Your letter of December 27 requested information on operating experience with field-erected pressure vessels. We have this information under preparation and expect to send it to you on January 13, 1967.

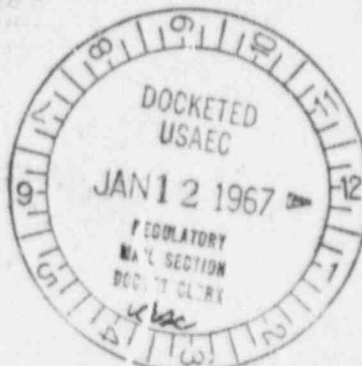
