

### A. DESCRIPTION

Reactor operator licensing examinations are scheduled at the nuclear power plant described below. Details of the examinations follow:

Contract examiners shall:

- Prepare two (2) simulator scenario sets
- Review walkthru exam outlines and prepare ten (10) associated administrative questions
- Submit written examinations, simulator scenarios, and/or walkthru exam outlines as appropriate to Regional office for review on a schedule consistent with the OLB Examiner Standards
- Incorporate changes to written exam, simulator scenarios, and/or walkthru exam outlines as appropriate
- Administer written examination at plant site
- Administer ten (10) operating examinations at plant site
- Grade ten (10) operating examinations
- Grade written examinations
- Update Examination Question Bank
- Attend exit briefing with facility

### B. PERIOD OF PERFORMANCE

The period of performance shall be from February 12, 1991 to May 10, 1991.

### C. REPORTS

The contractor shall submit Operator Examination Reports, summary sheets and other documentation as required by the Operator Licensing Examiner Standards, NUREG 1021, to the Regional office.
