SUBJECT: MEETING SUMMARY OF THE DECEMBER 5, 1983 MEETING WITH
PHILADELPHIA ELECTRIC COMPANY --PEACH BOTTOM ATOMIC
POWER STATION, UNITS 2 AND 3 EQUIPMENT QUALIFICATION
PROGRAM (MPA F-11 and B-60)

Members of the NRC staff met with representatives of the Philadelphia Electric Company (PECO or the licensee) on December 5, 1983. A list of the meeting attendees is provided as Enclosure 1. The purpose of the meeting was to discuss and resolve all outstanding issues pertaining to the Environmental Qualification (EQ) of Safety-Related Electrical Equipment as summarized in the staff's contractor report dated August 3, 1982 (Technical Evaluation Report, NRC-03-79-118, FRC Task 493). The licensee provided technical discussions of a wide variety of issues as outlined and summarized in Enclosure 2. Based upon the above presentation, the NRC staff asked that the licensee consider if any other pieces of equipment, not presented at the meeting, have been affected by the new NRC rule on equipment qualification. Also, the licensee was requested to consider and evaluate its Design Basis Accident (DBA) assumptions to ensure the appropriate harsh environments being considered in its EQ analysis.

The licensee agreed to pursue a prompt response to the NRC requests as a result of this meeting.
