SUBJECT: REQUEST BY HENRY MYERS FOR ZIMMER DOCUMENTATION

On April 21, 1982, Mr. Fred Combs, Office of Congressional Affairs, contacted Mr. A. Bert Davis of this office and forwarded a request from Dr. Henry Myers of Congressman Udall's staff for information related to Region III's Zimmer investigation.
