

Thank you for your letter dated July 18, 1977, which transmitted a proprietary replacement Table 3-1 for General Electric Company proprietary Report NEDE-20179 (Segmented Test Rod Bundle). Our letter to you dated February 11, 1974, approved withholding of NEDE-20179 and previous replacement Table 3-1.

Since the replacement Table 3-1 is primarily for updating the basic report, does not relate to any pending licensing actions and does not significantly change the data contained thereon, we will withhold it from public disclosure. If the basis for withholding NEDE-20179 from public disclosure should change in the future such that the information could then be made available for public inspection and copying, you should promptly notify the NRC.
