In accordance with Section G.5, <u>Task Order Procedures</u>, of the subject contract, this letter definitizes Task Order No. 135, Mod. 1 which increases the negotiated task order ceiling to allow for an additional contract examiner and provides funding in the amount of \$19,700.00. The amount of \$9,371.00 represents incremental funding for the basic task order and the remaining funds in the amount of \$10,329.00 is for Mod. 1. This effort shall be performed in accordance with the enclosed Statement of Work and Sonalysts, Inc.'s proposal (T/O-135, MOD 1) dated January 6, 1992, incorporated herein by reference.

The period of performance for Task Order No. 135, Mod. 1 is the same as the basic task order, December 21, 1991 through March 24, 1992. The total cost ceiling is hereby increased by \$10,329.00 from \$61,371.00 to \$71,700.00. The amount of represents the total estimated reimbursable cost,
