The purpose of this modification is to (1) provide funds in the amount of \$34,504.00, thereby increasing the obligated and ceiling amounts of the contract and (2) extend the period of performance. Accordingly, the following changes are hereby made:

1. Under Item 1., Paragraph B.3, Consideration and Obligation--Firm Fixed Price, the figure "\$99,295.95" is changed to read "\$133,799.95."
2. Under Section F.5 Duration of Contract Period (MAR 1987), is revised to read as follows:

"This contract shall commence on April 16, 1990 and will expire on August 31, 1991."

3. Under Section G.3, PAYMENT, Item No. c., is revised to read as follows:

"One payment in the amount of \$34,504.00 will be paid to the contractor upon submission and acceptance of the Staffing-up Report."

Note: The above payment represents authorization of payment for additional expenditures not included in the original proposal.

4. Under Section G.3, PAYMENT, Item No. d. is added to read as follows:

"Final payment in the amount of \$19,295.95 will be paid to the contractor upon receipt and acceptance of the final report required by paragraph F.6 herein."

All other terms and conditions under the contract remain unchanged.
